2, JS's Thu meeting w Jacob Fox didn't happen because JF double-booked himself at the same meeting time, leaving JS to wait half an hr before giving up. JS found later that JF had sent a last-minute email requesting to change the meeting time to 11:20, so late that it wasn't seen in time. Tommy asks JS for advice, doesn't get consistent guidance from JF. All GGC agreed to step back for the time being. If the City Clerk or someone creates a post, PW will share to Community of Geneva, Greener Geneva, City of Geneva Green Committee Facebook page, others share to Instagram, personal pages, etc. City previously agreed on several occasions to improve signage. JF asked at the joint Town/City meeting Monday for volunteers to help direct people (at least until better signage is provided), train people to keep plastic etc. out of compost, and help punch chits. Monitors needed. MC: there should be a compost bin at each Farmer's Market; most in agreement.
