# MESSAGE FROM THE CHIEF OF POLICE

Dear City Manager Hendrix,

I am honored to present to you the Geneva Police Department's 2022 Annual Report outlining the work that the Police Department completed throughout the year. We are committed to maintaining the professional level of police services that we provide every day. We are always conforming and changing the way we police the City of Geneva with the best interest of all citizens, residents, and visitors in mind. The 2022 year was like the past couple of years when it comes to our staffing level. We were down several positions for various reasons, and continue to try to fill the vacancies created by transfers, retirements, and promotions.

The Geneva Police Department suffered an enormous loss on July 4<sup>th</sup>, 2022 when Officer Timothy Peters, Badge #839, lost his short, but very courageous battle with Pancreatic Cancer. The loss of our brother was a shock to his family, his work family, and his friends. Officer Peters always had a smile on his face, and was always willing to help anyone out; including his fellow officers. Whether on or off duty, he was heavily involved in community policing. Officer Peters was an avid volunteer for events within the city, and events through the Aeneas McDonald Police Benevolent Association. In honor of Officer Peters' service to the City of Geneva for 18 years, the Geneva Police Department will be retiring Badge #839 so that it will forever belong to our brother and friend.

The OPIOID crisis remains a priority for the Geneva Police Department. We remain confident that the daily work we are performing in the Narcotics Unit, vehicle interdiction, and through general police investigations that we are making a difference, and making Geneva a safer place. NARCAN was administered by Geneva Police Officers on 13 different incidents. Through Ontario County Public Health, NARCAN is being carried by all Geneva Police Department who are trained and ready to respond when an overdose occurs. Our Narcotics Unit seized over 6.13 pounds of cocaine, and seized 8 firearms from our streets. The Narcotics Unit assisted several local, state and federal agencies during 2022, which spanned throughout the Finger Lakes region, and resulted in several pounds of narcotics taken off our streets.

# MESSAGE FROM THE CHIEF OF POLICE

The Geneva Police Department recorded 27,983 Calls for Service in 2022. This was a 9.19% decrease from 2021. Calls for Service encompass a variety of occurrences; including crimes against persons, crimes against property, family trouble and/or domestic violence calls, mental health crisis', civil complaints, neighbor disputes, traffic stops, property checks, assist agencies, special details and many others.

The Geneva Police Department used the Unified Crime Report (UCR) for reporting statistical data on crime in the City of Geneva. The UCR is broken down into Part I and Part 2 crimes. Part I crimes consist of two categories; violent crime and property crime. Part I crimes reported to the Geneva Police Department in 2022 totaled 338, which was an increase of approximately 52% from the previous year, in which we had 223. Part 2 crimes consist of crimes not included in Part I, and totaled 757 in 2022. This was an increase of approximately 10.5% from 2021, in which we had 685 reported. The department continues to stay up to date with the necessary training and resources needed to ensure crime victims are not left behind after a crime has been reported.

The Geneva Police Department remains committed to making Geneva a safer place to work, live and play through the critical work we perform daily. I want to thank the men and women of the Geneva Police Department for their integrity, professionalism, dedication, many hours of overtime, and service to the City of Geneva. The men and women of the police department work tirelessly to ensure the safety of all they come into contact with.

I would also like to extend my thanks to Geneva City Chief Court Clerk Margaret Mahoney and the court staff, District Attorney James Ritts and the Ontario County District Attorney's Office, Sheriff Philip Povero and the Ontario County Sheriff's Office Court Security assigned to Geneva City Court, our clerical staff, parking enforcement officer, and our school crossing guards for the work and dedication they all put into their respective positions. Without all mentioned above, the Geneva Police Department would not be the amazing agency we are.

# UNIFORMED DIVISION


In 2022, the Uniformed Division was comprised of 17 Police Officers and 1 School Resource Officer who cover four different shifts, and the Geneva City Schools. They are supervised by 6 Sergeants who are overseen by one Lieutenant who reports to the Chief of Police.

The Uniformed Division are the first responding officers handling calls that get called into 9-1-1 or come into the police station. Their response is to firstly secure the scene and give aid and comfort to the injured.


They handle simple complaints such as animal complaints, larcenies but also conduct the preliminary investigation for more serious crimes such as homicides, rapes, robberies, and assaults. They take a proactive approach to their patrol duties by looking out for suspicious activities, traffic offenses, and conducting property checks on residences, buildings, and businesses. The responsibilities of the Uniformed Division include parking and traffic enforcement, prisoner escorts, funeral escorts, investigations, as well as maintaining order at parades, public gatherings, and other community events.

Members of the Uniformed Division are active in specialized units such as evidence technicians, instructors, accident reconstructionist, fire investigators, hostage negotiators, crisis intervention officers, field training officers, and bicycle patrol.


# CITY PATROL MAP

# CALLS FOR SERVICE BY TYPE





The Geneva Police Department has 228 different types of signals (or the type of Call for Service).

The above graph depicts 16 common signals Officers respond to or self initiate.



## Total Traffic Tickets Written 2018-2022




## Total Speeding Tickets Written 2018 - 2022



Total D.W.I. Arrests in 2022





Total D.W.I. Arrests 2018 - 2022



# MOTOR VEHICLE ACCIDENTS BY DAY OF THE WEEK








# DRUG OVERDOSE REPORT





# SEXUAL OFFENDER MANAGEMENT

Currently, there are six (6) Police Officers, one (1) Administrative Aide, and one (1) Sergeant assigned to the management of Sex Offenders residing within the city. Responsibilities of the officers include monthly residence checks where officers stop and speak with each Sex Offender at their residence to confirm residency and investigations of alleged violations. Staff is also responsible for maintaining a 90-day verification log for all Level 3 Sex Offenders, and Sexual Predators, change of address updates as well as updated photos.

Investigations are conducted on all Sex Offenders who fail to notify this agency of a change of address as well as any complaints received from the public regarding a Sex Offender. Also being investigated are complaints or discovery of sex offenders utilizing social media and internet accounts that are not registered as required by corrections law.

Currently, there are 51 NYS Registered Sex Offenders residing within the City of Geneva. NYS Sex Offender Registry divides Sex Offenders into 3 Levels: 1, 2, and 3. Currently residing within the City of Geneva there are:

Per NYS DCJS the Levels are defined as:

Level 1 - low risk of repeat offense

Level 2 - moderate risk of repeat offense

Level 3 - high risk of repeat offense and a threat to public safety exists

# DETECTIVE BUREAU

In 2022, the Detective Bureau was comprised of three Detectives, one is assigned to Major Crimes, the second is assigned to Narcotics, and the third is assigned to the Family Services Unit. There is also one Police Officer who is assigned to Narcotics for training when staffing allows. All are supervised by one Lieutenant who reports to the Chief of Police. The Detective Bureau handles a vast variety of investigations including narcotics activity, missing persons, and major crimes such as homicides, robberies, aggravated assaults, sexual assaults, and burglaries.

The Criminal Investigation Division (CID), handles major crimes usually at the felony level and/or those crimes that are complex and require numerous investigative hours. The Family Services Unit investigates crimes where the suspects, and in some cases, the victims are juveniles. The Family Services Unit also handles those cases involving juveniles which are of the violation level and cannot be sent to Family Court. They work closely with SRO's, Child Protective, Child Advocacy Center, Probation, and Youth Court. The Drug Enforcement Unit investigates cases which are associated with narcotics, gambling, firearms, and prostitution. Members of the DEU also assist in the investigation of violent crimes. They work closely with local law enforcement agencies from surrounding counties along with state and federal agencies.


Along with their investigative duties, members of the Detective Bureau, also serve in specialized units such as evidence technicians, evidence aids, instructors, bicycle patrol and the Ontario County SWAT Team.



## EVIDENCE & PROPERTY MANAGEMENT

The Detective Bureau is tasked with processing all evidence and property. During the year 2022, 742 items of evidence or property were received. The Detective Bureau also processes and submits Body Worn Camera footage to the District Attorney's Office, the County Attorney's Office and other law enforcement agencies. Additionally, 240 items of evidence or property were disposed of or destroyed, and 52 items were transferred to the Crime Lab for processing. The Detective Bureau transfers all evidence to and from other agencies and the District Attorney's Office. There was a total of 7,756 photographs taken from crime scenes and motor vehicle accidents. There were 14 recovered bicycles that were donated back to the community.

The Geneva Police Department received and destroyed 647 pounds of unused medication.




# UNIFORM CRIME REPORT

The Uniform Crime Report (UCR) Program divides offenses into two groups, Part I and Part II crimes. Each month, participating law enforcement agencies submit information on the number of Part I offenses that become known to them; those offenses cleared by arrest or exceptional means; and the age, sex, and race of persons arrested for each of the offenses. Contributors provide only arrest data for Part II offenses.


The UCR Program collects data about Part I offenses in order to measure the level and scope of crimes occurring throughout the Nation. The program's founders chose these offenses because they are serious crimes, they occur with regularity in all areas of the country, and they are likely to be reported to the police.

# D.A.R.E.<sup>®</sup>

TEACHING STUDENTS DECISION MAKING  
FOR SAFE & HEALTHY LIVING

D.A.R.E. stands for Drug Abuse Resistance Education. It was started in the early 1980's in California and has spread across the country. Geneva is celebrating its 33<sup>rd</sup> year of the D.A.R.E. program, which started in the 1989-1990 school year. There are two D.A.R.E. Officers in the Geneva Police Department. They teach 3<sup>rd</sup>, 4<sup>th</sup>, and 5<sup>th</sup> grades at North Street School, as well as St. Frances - St. Stephen's School over a 10-week period.

During the 2021-2022 school year, the Geneva D.A.R.E Officers taught over 200 students in the Geneva and St. Stephen's School Districts, ranging in age from 9 to 11. The Geneva D.A.R.E program is a partnership between the school district and the police department to teach safety, anti-bullying, and assist students with making healthy choices throughout their lives. The D.A.R.E. curriculum is a classroom presentation to elementary students by law enforcement officers in cooperation with a NYS certified teacher. The curriculum features both decision making and skill building models for effective ways to refuse drugs and make healthy decisions. Lessons include substance use and abuse, communication skills, peer pressure, bullying, and helping the community.

Students are expected to foster a positive relationship with the D.A.R.E. officer, participate in cooperative learning groups, participate in role-play activities, and develop questions to promote higher level thinking.

# DCJS ADMINISTRATIVE STUDY

In October 2021, at the request of Michael J. Passalacqua, Chief of Police for the Geneva Police Department (GPD), OPS initiated an administrative study to examine staffing within the agency. In accordance with DCJS procedures, a consultant versed in law enforcement administration, operations, organizational structure, and staffing was selected to assist OPS staff with data collection and analysis for the purposes of developing the study. The consultant, under the supervision of OPS staff, was given the authority to examine all relevant data and documents and meet with appropriate members of GPD to obtain the information necessary to complete the study. For the purposes of this study, Chief Passalacqua identified staffing, operational objectives, and the efficient and effective deployment of resources as primary concerns.
